11	Section 1. R.S. 33:2541.5 is hereby enacted to read as follows:		
12	§2541.5. Winn Parish Fire Protection District No. 3; fire chief and assistant fire		
13	chief; unclassified service		
14	Notwithstanding any provision of law to the contrary, the positions of fire		
15	chief and assistant fire chief for Winn Parish Fire Protection District No. 3 are in the		
16	unclassified service, and the right of selection, appointment, supervision, and		
17	discharge for such positions is vested in the governing board of the district.		
18	Section 2. This Act shall become effective upon signature by the governor or, if not		
19	signed by the governor, upon expiration of the time for bills to become law without signature		
20	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

Abstract: Relative to the positions of fire chief and assistant fire chief for Winn Parish Fire Protection District No. 3, provides that the positions are in the unclassified service. Provides further with respect to the right of selection, appointment, supervision, and discharge for such position.

<u>Present constitution</u> creates a fire and police civil service system applicable to municipalities of over 13,000 in population and parishes and fire protection districts. Provides that the system is subject to Art. XIV, §15.1 of the 1921 constitution made statutory by the 1974 constitution.

<u>Present law</u> creates and provides for two fire and police civil service systems: (1) one applicable to any municipality which operates paid police and fire departments and which has a population of not fewer than 13,000 persons; and (2) one applicable to any parish, fire protection district, or municipality with a population of fewer than 13,000, but not fewer than 7,000 persons.

Proposed law retains present law.

<u>Present law</u> relative to both systems, provides that the classified service shall comprise every position, except those in the unclassified service, to which the right of employee selection, appointment, supervision, and discharge is vested in the municipal government. Provides that the positions of fire chief and police chief shall be in the classified service. Provides further with respect to which positions are in the classified and unclassified service.

<u>Proposed law</u> retains <u>present law</u> but provides an exception for the positions of fire chief and assistant fire chief for Winn Parish Fire Protection District No. 3. Provides that such positions are in the unclassified service, and provides that the right of selection, appointment, supervision, and discharge for such positions is vested in the governing board of the district.

Effective upon signature of governor or lapse of time for gubernatorial action.
