## COURTS/CITY: Provides for the disposal of certain misdemeanor records

1	AN ACT
2	To amend and reenact R.S. 13:1904(D), relative to the destruction of certain misdemeanor
3	records; to authorize certain clerks of court to destroy certain misdemeanor records;
4	and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 13:1904(D) is hereby amended and reenacted to read as follows:
7	§1904. City courts; destruction of useless records; certain courts
8	* * *
9	D. The clerk of the City Court of Hammond, the clerk of the City Court of
10	Houma, the clerk of the City Court of Ruston, and the clerk of the City Court of Lake
11	Charles may, upon consent of the judge or of the majority of judges if there is more
12	than one city judge and with authorization from the state archivist as provided in R.S.
13	44:411, destroy records of criminal proceedings involving misdemeanor convictions
14	when such records have been deemed by the presiding judge or judges to have no
15	further use or value. However, such proposed destruction shall be authorized only
16	when ten years have elapsed from the date of the judgment of conviction when the
17	conviction is not appealed or two years have elapsed after all appeals are exhausted.
18	The provisions of this Subsection shall not apply to a conviction for operating a
19	vehicle while intoxicated.

Abstract: Adds the clerk of the City Court of Hammond to the list of clerks of court who may destroy certain misdemeanor records which have been deemed to be of no further use or value.

<u>Present law</u> authorizes the clerks of the city courts of Houma, Ruston, and Lake Charles, upon consent of the judge or of the majority of judges if there is more than one city judge and with authorization from the state archivist, to destroy records of criminal proceedings involving misdemeanor convictions when 10 years have elapsed from the date of the judgment of conviction

<u>Present law</u> does not apply to a conviction for operating a vehicle while intoxicated.

<u>Present law</u> requires the clerk of court to scan and store the records in electronic format prior to destruction.

<u>Proposed law</u> retains <u>present law</u> and adds the clerk of the City Court of Hammond to those clerks of court who may destroy records pursuant to <u>present law</u>.
