2	To amend and reenact R.S. 47:9029(A)(3), relative to the Louisiana Lottery Corporation

6	Section 1. R.S. $47:9029(A)(3)$ is hereby amended and reenacted to read as follows:		
7	§9029. Deposit of revenues; expenditures and investments authorized; transfer of		
8	revenues to state treasury; dedication and use of proceeds; corporation

12	(3) Within twenty days following the close of each calendar month, the		
13	corporation shall transfer to the Lottery Proceeds Fund in the state treasury the		
14	amount of net revenues which the corporation determines are surplus to its needs.		
15	Net revenues or proceeds shall be determined by deducting from gross revenues the		
16	payment costs incurred or estimated to be incurred in the operation and		
17	administration of the lottery. This shall include the expenses of the corporation and		
18	the costs resulting from any contract or contracts entered into for promotional,		
19	advertising, or operational services or for the purchase or lease of lottery equipment		
20	and materials, fixed capital outlays, and the payment of prizes to the holders of

- 1 winning tickets. After the first year of operation the corporation shall transfer each

Abstract: Increases the minimum percentage of gross revenues transferred to the state treasury by the Louisiana Lottery Corp. from 35% to 50% of gross revenues.

<u>Present law</u> requires the Louisiana Lottery Corporation to transfer to the Lottery Proceeds Fund the amount of net revenues the corporation determines to be in excess of its needs. Specifies that the corporation shall transfer each year at least 35% of gross revenues to the state treasury.

<u>Proposed law</u> increases the required percentage of gross revenues transferred from 35% to 50%.
