2	To enact R.S. 37:695.1, relative to engineers; to provide for powers and duties of the
3	Louisiana Professional Engineering and Land Surveying Board; to provide for
4	qualifications; to provide for waivers of certain requirements; to provide certain
5	procedures and conditions; to provide for an effective date; and to provide for related
6	matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 37:695.1 is hereby enacted to read as follows:
9	§695.1. Waiver of the fundamentals of engineering exam
10	A. On and after January 1, 2017, an applicant shall not be required to
11	take the examination in the fundamental engineering subjects if he meets all of
12	the following requirements:
13	(1) Holds an engineering degree. The board shall by rule set forth the
14	types of approved or recognized engineering degrees, including baccalaureate
15	and graduate degrees.
16	(2) Possesses qualifying engineering work experience. The board shall
17	by rule set forth the type and minimum number of years of qualifying

2	held by the applicant, the requisite work experience required under this

4	(3) Has successfully completed the principles and practice of engineering
5	examination.
6	(4) Holds an active license to engage in the practice of engineering issued
7	to him by proper authority of another state, territory, or possession of the
8	United States, or the District of Columbia, or within the past five years from the
9	date of application has held an active license to engage in the practice of
10	engineering issued to him by proper authority of another state, territory, or
11	possession of the United States, or the District of Columbia. The board shall by
12	rule set forth the minimum number of years of engineering licensure in the
13	other jurisdiction.
14	(5) Has no history of disciplinary action and no disciplinary proceeding
15	pending against him by an engineering licensing authority of another state,
16	territory, or possession of the United States, or the District of Columbia.
17	<b>B.</b> The board shall adopt rules in accordance with the Administrative
18	<b>Procedure Act to implement the provisions of this Section by January 1, 2017.</b>
19	Section 2. This Act shall become effective upon signature by the governor or, if not
20	signed by the governor, upon expiration of the time for bills to become law without signature
21	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
22	vetoed by the governor and subsequently approved by the legislature, this Act shall become
23	effective on the day following such approval.

Present law provides for qualifications of professional engineers in La.

<u>Proposed law</u> provides that on and after January 1, 2017, an applicant shall not be required to take the examination in the fundamental engineering subjects if he meets all of the following requirements:

The board shall by rule set forth the minimum number of years of engineering licensure in the other jurisdiction.
- (5) Has no history of disciplinary action and no disciplinary proceeding pending against him by an engineering licensing authority of another state, territory, or possession of the United States, or the District of Columbia.

<u>Proposed law</u> provides that the board shall adopt rules in accordance with the Administrative Procedure Act to implement the provisions of <u>proposed law</u> by January 1, 2017.

Effective upon signature of the governor or lapse of time for gubernatorial action.
