AGRICULTURE: Provides relative to the state soil and water conservation commission

1 AN ACT

2 To amend and reenact R.S. 3:1204(A)(1)(a)(introductory paragraph) and (C)(3), relative to
3 the state soil and water conservation commission; to modify the membership of the
4 soil and water conservation commission; to remove the requirement that the
5 Department of Agriculture and Forestry perform audits on the state soil and water
6 commission; and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 3:1204(A)(1)(a)(introductory paragraph) and (C)(3) is hereby
9 amended and reenacted to read as follows:

10 §1204. State soil and water conservation commission

11 A.(1)(a) There is hereby established, to serve as an agency of the state and
12 to perform the functions conferred upon it in this Part, a state soil and water
13 conservation commission. The commission shall consist of eight members. The
14 ~~chancellor of the Louisiana State University Agricultural Center~~ Louisiana State
15 University Vice President of Agriculture and Dean of the College of Agriculture, the
16 commissioner of agriculture and forestry of Louisiana, and the president of the
17 Louisiana Association of Conservation Districts shall automatically be members of
18 this commission. Each shall designate a person to represent him at meetings at
19 which he cannot be present, and the person so designated by each shall serve, in the
20 absence of the officer who selects him, with the same power and authority as that

1 officer, including the right to vote. In the case of the Louisiana Association of
2 Conservation Districts president, his alternate shall be the vice president of the
3 association. The other five members shall be elected, one from each of the following
4 areas of the state:

8 (3) The commission shall provide for the execution of surety bonds for all
9 employees and officers who shall be entrusted with funds or property; shall provide
10 for the keeping of a full and accurate record of all proceedings and all resolutions,
11 regulations, and orders issued or adopted; shall provide for an annual examination
12 of the accounts of receipts and disbursements and an annual examination of all
13 districts; and shall provide for a complete audit at least once every four years of the
14 accounts of receipts and disbursements ~~and of~~ all districts, ~~all of~~ which shall be
15 performed by the audit and evaluation section of the Department of Agriculture and
16 Forestry and filed with the legislative auditor.

Abstract: Provides relative to the membership of the state soil and water conservation commission and who performs audits for all of the commissions districts.

Present law specifies that the chancellor of the Louisiana State University Agriculture Center is a member of the state soil and water conservation commission.

Proposed law modifies present law by replacing the chancellor of the Louisiana State University Agriculture Center with the Louisiana State University Vice President for Agriculture and Dean of the College of Agriculture.

Present law requires audits at least once every four years for all districts within the state soil and water conservation commission to be performed by the audit and evaluation section of the Dept. of Agriculture and Forestry and filed with the legislative auditor.

Proposed law modifies present law by removing the requirement that the audit be performed by the audit and evaluation section of the Dept. of Agriculture and Forestry.
