7	to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. The sum of Six Thousand Sixty-Two and 50/100 (\$6,062.50) Dollars is
10	hereby appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2016-
11	2017 to be used to pay the consent judgment in the suit entitled "Zurich American Insurance
12	Company v. Adrian D. Gourley, McLane Company, Inc., Transco, Inc., Aon Rish Services
13	Southwest, Inc., Gulf Engineers and Consultants, Inc. and the State of Louisiana through the
14	Department of Transportation and Development", bearing Number 17506, Division "E", on

17	Section 2. This Act shall become effective on July 1, 2016; if vetoed by the governor
18	and subsequently approved by the legislature, this Act shall become effective on July 1,
19	2016, or on the day following such approval by the legislature, whichever is later.
