Abstract: Requires the Dept. of Public Safety and Corrections, office of motor vehicles, to make license plates available to each public license tag agent. Requires public license tag agents to remit the costs of production of the plates and requires them to submit all required documents in the method or form required by the department.

<u>Present law</u> authorizes the commissioner to establish a system of public license tag agents to collect the registration license taxes. Specifies that the system is to consist of municipal and parish governing authorities or new motor vehicle dealers or their agents as well as authorized auto title companies.

<u>Present law</u> authorizes public license tag agents to issue registration certificates and license plates to vehicles and motor vehicles.

<u>Proposed law</u> retains <u>present law</u> and requires that license plates be made available to each public license tag agent in increments of no less than 10. Requires public license tag agents to remit the costs of production for the license plates prior to receipt of the license plates.

<u>Proposed law</u> requires public license tag agents to submit all required documents to the Dept. of Public Safety and Corrections, office of motor vehicles, in the method or form required by the department.
