## AGRICULTURE: Modifies the composition of the La. Crawfish Promotion and Research Board

2	To amend and reenact R.S. 3:556.3(B)(introductory paragraph), (3), and (4) and to repeal
3	R.S. 3:556.3(B)(10), relative to the Louisiana Crawfish Promotion and Research
4	Board; to provide for the modification of the composition of the board; and to
5	provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 3:556.3(B)(introductory paragraph), (3), and (4) are hereby amended
8	and reenacted to read as follows:
9	§556.3. Louisiana Crawfish Promotion and Research Board

11	B. The board shall consist of thirteen eleven members appointed by the
12	commissioner of agriculture and forestry in accordance with the following
13	provisions:

15	(3) One member who is engaged in crawfish farming north of U.S. Highway
16	190 appointed from a list of three persons nominated by the Louisiana Crawfish
17	Farmers Association.
18	(4) Four <u>Three</u> members engaged in harvesting wild crawfish.

20	Section 2. R.S. 3:556.3(B)(10) is hereby repealed in its entirety.

Abstract: Changes the composition of the Louisiana Crawfish Promotion and Research Board.

Present law provides for the La. Crawfish Promotion and Research Board to be composed of 13 members appointed by the commissioner of agriculture and forestry as follows: (1) One member engaged in crawfish farming east of the Atchafalaya River appointed from a list of three persons nominated by the Louisiana Crawfish Farmers Association, (2) One member who is engaged in crawfish farming west of the Atchafalaya River and south of U.S. Highway 190 appointed from a list of three persons nominated by the Louisiana Crawfish Farmers Association, (3) One member who is engaged in crawfish farming north of U.S. Highway 190 appointed from a list of three persons nominated by the Louisiana Crawfish Farmers Association, (4) Four members engaged in harvesting wild crawfish, (5) One member who is engaged in crawfish farming or crawfish harvesting appointed from a list of three persons nominated by the Louisiana Farm Bureau Federation, (6) One member who is an owner or operator of a facility which produces artificial crawfish bait, (7) One member who is an owner or operator of a facility which processes crawfish, (8) One member appointed from a list of three persons nominated by the Louisiana Restaurant Association, (9) One member appointed who owns or operates a retail crawfish-seafood facility, appointed from the state at large, and (10) One member who is a landowner engaged in commercial crawfish leasing appointed from a list of three persons nominated by the Louisiana Landowners Association.

<u>Proposed law</u> modifies <u>present law</u> by reducing the size of the board <u>from</u> 13 members to 11 members. Specifically, removes the requirement that one of the crawfish farmers appointed to the board has to be engaged with crawfish farming north of U.S. Highway 190. It also reduces the numbers of appointed members who engage in harvesting wild crawfish <u>from</u> four members to three members, and repeals the one member who is a landowner engaged in commercial crawfish leasing.
