5	repealed.
6	Section 2. Chapter 5-G of Title 25 of the Louisiana Revised Statutes of 1950,
7	comprised of R.S. 25:380.41 through 380.46, and R.S. 36:744(P) and 801.11 are hereby
8	repealed.
9	Section 3. Chapter 5-H of Title 25 of the Louisiana Revised Statutes of 1950,
10	comprised of R.S. 25:380.51 through 380.56, and R.S. 36:744(S) and 801.12 are hereby
11	repealed.
12	Section 4. Chapter 5-I of Title 25 of the Louisiana Revised Statutes of 1950,
13	comprised of R.S. 25:380.61 through 380.66, and R.S. 36:744(T) and 801.13 are hereby
14	repealed.
15	Section 5. Chapter 5-J of Title 25 of the Louisiana Revised Statutes of 1950,
16	comprised of R.S. 25:380.71 through 380.76, and R.S. 36:744(U) are hereby repealed.
17	Section 6. Chapter 5-K of Title 25 of the Louisiana Revised Statutes of 1950,

19	repealed.
20	Section 7. Chapter 5-M of Title 25 of the Louisiana Revised Statutes of 1950,

22	repealed.
23	Section 8. Chapter 5-O of Title 25 of the Louisiana Revised Statutes of 1950,
24	comprised of R.S. 25:380.121 through 380.126, and R.S. 36:744(Z) and 801.19 are hereby
25	repealed.
26	Section 9. Chapter 5-P of Title 25 of the Louisiana Revised Statutes of 1950,
27	comprised of R.S. 25:380.131 through 380.136, and R.S. 36:744(AA) and 801.20 are hereby
28	repealed.
29	Section 10. This Act shall become effective upon signature by the governor or, if not

- signed by the governor, upon expiration of the time for bills to become law without signature
- by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 3 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 4 effective on the day following such approval.

<u>Present law</u> establishes the Louisiana State Oil and Gas Museum, the Livingston Parish Museum and Cultural Center, the Louisiana Delta Music Museum, the Louisiana Military Museum, the Jean Lafitte Marine Fisheries Museum, the Tioga Heritage Park and Museum, the Shreveport Water Works Museum, the Spring Street Historical Museum, and the Louisiana Military Hall of Fame and Museum under the jurisdiction of the Department of State.

Proposed law repeals present law.

Effective upon signature of the governor or lapse of time for gubernatorial action.

(Repeals R.S. 25:380.21-380.26, 380.41-380.46, 380.51-380.56, 380.61-380.66, 380.71-380.76, 380.81-380.86, 380.101-380.106, 380.121-380.126, and 380.131-380.136, and R.S. 36:744(N), (P), (S), (T), (U), (V), (X), (Z), and (AA), 801.9, 801.11, 801.12, 801.13, 801.15, 801.17, 801.19, and 801.20)
