REGISTRARS OF VOTERS OR NO Provides qualifications for the office of registrar of voters

<u>Proposed law</u> retains <u>present law</u> requiring registrars of voters to be registered voters in the State of Louisiana. <u>Proposed law</u> further provides that registrars of voters must maintain residency and voter registration in the parish in which they perform their duties and must have at least one of the following qualifications when appointed: a baccalaureate degree and three years of full-time, professional work experience; nine years of full-time, professional work experience; or six years of full-time employment in a registrar's office in LA. <u>Proposed law</u> defines "full-time, professional work experience." <u>Proposed law</u> provides that provisions added to qualifications of registrars of voters shall not be retroactive and not apply to current registrars. <u>Proposed law</u> will become effective if and when a proposed amendment to Article XI, Section 5 of the Constitution of Louisiana to be introduced in a separate House Bill introduced during the 2016 Regular Session is adopted at a statewide election and becomes effective.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The proposed law outlines new qualifications for persons to serve as registrars of voters and provides that the new qualifications will not apply retroactively to current registrars.

The proposed law will not become effective until a constitutional amendment to be introduced in a separate House Bill during the 2016 Regular Session is adopted at a statewide election and becomes effective. As a regular practice, the Secretary of State typically budgets for up to 10 constitutional amendments and statewide propositions for the fall statewide elections. To the extent the ballot includes more than 10 constitutional amendments and statewide propositions, the Secretary of State may require additional resources for the November 8, 2016 statewide election.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
