8	Biology and Anatomy in 2006; and
9	WHEREAS, Dr. Dunn obtained certification from the American Board of Physical
10	Therapy Specialties in Orthopaedic Physical Therapy in 1996, was recertified in 2006 and
11	utilizes this content expertise in her teaching, research and clinical practice; and

6	Therapy Association with her term expiring in 2018; and
7	WHEREAS, Dr. Dunn has a passion for advocacy, member engagement, and the

10	International Society for Hyaluronan Science, and in 2009 cofounded The Edge Physical
11	Therapy, LLC in Shreveport; and
