MUSEUMS. Transfers the Eddie G. Robinson Museum from the jurisdiction of the Department of State to the Board of Supervisors for the University of Louisiana System. (gov sig)

1	AN ACT
2	To amend and reenact R.S. 25:1242, 1243(B)(3), and 1244, and R.S. 36:919.6, to enact R.S.
3	36:651(DD), and to repeal R.S. 25:1245 and 1246 and R.S. 36:744(Q), relative to the
4	Eddie G. Robinson Museum; to transfer the jurisdiction over the museum from the
5	Department of State to the Board of Supervisors for the University of Louisiana
6	System; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 25:1242, 1243(B)(3), and 1244 are hereby amended and reenacted
9	to read as follows:
10	§1242. Creation; domicile; membership
11	A. The Eddie G. Robinson Museum Commission, hereinafter referred to as
12	"commission", is hereby created in the Department of State Education under the
13	management and supervision of the Board of Supervisors for the University of
14	Louisiana System.
15	B. The domicile of the commission shall be at Grambling State University
16	in Grambling, Louisiana.
17	C. The commission shall include the following members:

1	(1) Seven members shall be appointed by the secretary of state chair of the
2	Board of Supervisors for the University of Louisiana System, subject to

6	(a) The president of Grambling State University or his designee.
7	(b) The mayor of the city of Grambling.
8	(c) The president of the Grambling Chamber of Commerce.
9	(d) The president of the Grambling State University National Alumni
10	Association or his designee.
11	(e) The athletic director at Grambling State University.
12	(f) The head football coach at Grambling State University.
13	(g) The president of the Grambling State University Athletic Foundation.
14	(h) The secretary of state chair of the Board of Supervisors for the
15	University of Louisiana System or his designee.
16	D. Members of the commission shall serve without compensation.

26	The secretary of the state Board of Supervisors for the University of
27	Louisiana System and the commission, jointly or separately, may solicit, accept,
28	use, and dispose of any private or public funds in the form of donations of money,

2	Section 2. R.S. 36:919.6 is hereby amended and reenacted and R.S. 36:651(DD) is
3	hereby enacted to read as follows:
4	§651. Transfer of boards, commissions, departments, and agencies to Department of
5	Education; boards, commissions, and agencies within Department of
6	Education

8	(DD) The Eddie G. Robinson Museum is hereby placed within the
9	Department of Education under the management and supervision of the Board
10	of Supervisors for the University of Louisiana System.

12	§919.6. Transfer; Eddie G. Robinson Museum Commission
13	The Eddie G. Robinson Museum Commission is placed in the Department
14	of State within the Department of Education under the management and
15	supervision of the Board of Supervisors for the University of Louisiana System
16	and shall exercise and perform its powers, duties, functions, and responsibilities as
17	provided for agencies transferred as provided in this Part. In addition, the
18	commission may solicit and accept gifts and donations for the purposes of the
19	museum. Any funds so accepted may be expended by the department board as
20	otherwise provided by law.
21	Section 3. R.S. 25:1245 and 1246 are hereby repealed.
22	Section 4. R.S. 36:744(Q) is hereby repealed.
23	Section 5. This Act shall become effective upon signature by the governor or, if not
24	signed by the governor, upon expiration of the time for bills to become law without signature
25	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
26	vetoed by the governor and subsequently approved by the legislature, this Act shall become
27	effective on the day following such approval.

<u>Present law</u> establishes the Eddie G. Robinson Museum under the overall jurisdiction of the Dept. of State.
