EXPENDITURE EXPLANATION

Proposed legislation will decrease expenditures for the Secretary of State. This bill repeals statutes associated with the Chennault Aviation and Military Museum of LA in order to remove the museum from the jurisdiction of the Secretary of State. While the bill does not specifically mention transferring the museum to a local governing authority, the Secretary of State indicated that the transfer of the museum to the Ouachita Parish School Board has been ongoing, with the board assuming a majority of costs prior to FY 16. The Secretary of State only incurred a total of \$18,188 (\$14,513 personal services, \$3,675 operating costs) in expenditures associated with the museum during the first quarter of FY 16.

For reference, in FY 15 the Secretary of State expended \$109,338 (\$54,764 personal services, \$54,574 operating costs) on the museum.

NOTE: To the extent that this museum reverts to the local governing authorities, a similar level of expenditures may result.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
