Prohibits and provides criminal penalties for the use of unmanned aircraft in certain areas and for certain purposes

Proposed law prohibits the use of unmanned aircraft as follows: (1) In the airspace, directly above privately owned immovable property, up to a height of 350 feet from the ground without the express or legal consent of the property owner; and (2) To conduct surveillance of, gather evidence or collect information about, or photographically or electronically record an individual or privately owned immovable property without the express or legal consent of the individual or the property owner; or, if the privately owned immovable property is occupied by a person other than the property owner, without the express or legal consent of both the property owner and the person occupying or residing upon the property. Whoever violates the provisions of proposed law shall be fined not more than \$500, imprisoned for not more than six months, or both. Proposed law defines "unmanned aircraft" as an aircraft that is operated without the possibility of direct human intervention from within or on the aircraft. 

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on state governmental expenditures as a result of this measure. Proposed law creates a misdemeanor offense associated with the use of an unmanned aircraft in certain areas and for certain purposes. Violators of proposed law shall be fined not more than \$500, imprisoned for not more than six months, or both. To the extent offenders may be imprisoned as a result of proposed law, any increase in expenditures would be at the local level.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on state governmental revenues as a result of this measure. Any fines imposed are associated with a misdemeanor and will be local revenue. Proposed law provides for a fine of not more than \$500 for violations utilizing unmanned aircraft.


