## HIGHWAYS: Revises route designations for certain byways

1	AN ACT
2	To enact R.S. 56:1948.5(67), (68), and (69) and to repeal R.S. 56:1948.5(2), (15), (57), and
3	(60), relative to Louisiana Byways designations; to repeal provisions of law
4	designating certain highways and sections of highways as Louisiana Byways; to
5	designate certain highways and sections of highways as Louisiana Byways; and to
6	provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 56:1948.5(67), (68), and (69) are hereby enacted to read as follows:
9	§1948.5. Louisiana Byways designations
10	The following highways and sections of highways are hereby designated as
11	Louisiana Byways:

13	(67) Myths and Legend Byway:
14	(a) US 165 from its intersection with US 190 in Kinder northeast to its
15	intersection with LA 26 in Oberlin in Allen Parish.
16	(b) LA 26 from its intersection with US 165 in Oberlin northwest to its
17	intersection with US 171 in Allen and Beauregard parishes.
18	(c) LA 113 from its intersection with LA 26 north to its intersection with LA
19	10 in Pitkin including its routing through Sugartown in Beauregard and Vernon
20	parishes.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

1	(d) LA 10 from its intersection with US 165 in Oakdale west to its
2	intersection with US 171 south of Pickering including its routing through Elizabeth,
3	Pitkin, Cravens, and Sandy Hill in Allen and Vernon parishes.
4	(e) LA 458 from its intersection with LA 10 in Pitkin northwest to its
5	intersection with LA 399 in Fullerton in Vernon Parish.
6	(f) LA 399 from its intersection with LA 10 northeast to its intersection with
7	Fullerton Lake Road, the entrance to Fullerton Lake Campground and Picnic area,
8	including its routing through Fullerton in Vernon Parish.
9	(g) US 112 from its intersection with LA 113 in Sugartown west to its
10	intersection with US 171 in Beauregard Parish.
11	(h) US 171 from its intersection with LA 26 west and north to its intersection
12	with LA 10 south of Pickering including its routing through Deridder and Rosepine
13	in Beauregard and Vernon parishes.
14	(i) US 190 from its intersection with US 171 in Deridder west to the
15	Louisiana-Texas state border including its routing through Merryville in Beauregard
16	Parish.
17	(j) LA 111 from its intersection with US 190 north to its intersection with
18	LA 8 in Beauregard and Vernon parishes.
19	(k) LA 8 from its intersection with LA 111 west to the Louisiana-Texas state
20	border in Vernon Parish.
21	(68) Zydeco Cajun Prairie Scenic Byway:
22	(a) US 90 from its intersection with LA 35 in Rayne west to its intersection
23	with LA 13 in Crowley in Acadia Parish.
24	(b) LA 35 from its intersection with US 90 in Rayne north to its intersection
25	with LA 95 in Church Point in Acadia Parish.
26	(c) LA 95 from its intersection with LA 35 southeast to its intersection with
27	LA 178 in Church Point in Acadia Parish.
28	(d) LA 178 from its intersection with LA 95 in Church Point east to its
29	intersection with LA 182 in Acadia and St. Landry parishes.

1	(e) LA 13 from its intersection with US 90 in Crowley north to its
2	intersection with US 167 including its routing through Eunice, Pine Prairie, and
3	Turkey Creek in Acadia, Evangeline, and St. Landry parishes.
4	(f) LA 370 from its intersection with LA 35 west to its intersection with LA
5	<u>13 in Acadia Parish.</u>
6	(g) US 190 from its intersection with LA 105 in Krotz Springs west to its
7	intersection with LA 1157-2 in Basile, including its routing through Port Barre,
8	Opelousas, and Eunice in St. Landry and Evangeline parishes.
9	(h) LA 1157-2 from its intersection with US 190 north to its intersection with
10	LA 1157-1 in Basile in Evangeline Parish.
11	(i) LA 3277 from its intersection with US 190 north to its intersection with
12	LA 1157-1 in Basile in Evangeline Parish.
13	(j) LA 1157-1 from its intersection with LA 3277 west to its intersection
14	with LA 1157-2 in Basile in Evangeline Parish.
15	(k) LA 182 from its intersection with LA 93 in Sunset west and north to its
16	intersection with LA 103 in Washington including its routing through Opelousas in
17	St. Landry Parish.
18	(1) LA 93 from its intersection with LA 31 in Arnaudville west to its
19	intersection with LA 182 in Sunset including its routing through Grand Coteau in St.
20	Martin and St. Landry parishes.
21	(m) LA 31 from its intersection with LA 93 in Arnaudville north to its
22	intersection with LA 103 in Leonville in St. Martin and St. Landry parishes.
23	(n) LA 103 from its intersection with LA 31 in Leonville north to its
24	intersection with LA 741 in Port Barre in St. Landry Parish.
25	(o) LA 758 from its intersection with US 190 north to its intersection with
26	LA 29 in St. Landry and Evangeline parishes.
27	(p) LA 29 from its intersection with LA 758 northeast to its intersection with
28	LA 1174 in Chataignier in Evangeline Parish.

1	(q) LA 1174 from its intersection with LA 29 north and east to its		
2	intersection again with LA 29 all in Chataignier in Evangeline Parish.		
3	(r) LA 105 from its intersection with US 190 in Krotz Springs north to its		
4	intersection with LA 10 in Melville in St. Landry Parish.		
5	(s) LA 10 from its intersection with LA 105 in Melville west and south to its		
6	intersection with LA 10 in Washington including its routing through Palmetto in St.		
7	Landry Parish.		
8	(t) US 167 from its intersection with I-49 west and north to its intersection		
9	with LA 3042 in Ville Platte in St. Landry and Evangeline parishes.		
10	(u) LA 3042 from its intersection with US 167 in Ville Platte north to its		
11	intersection with LA 106 in Evangeline Parish.		
12	(v) LA 106 from its intersection with I-49 west to its intersection with US		
13	167 in Avoyelles and Evangeline parishes.		
14	(w) US 167 from its intersection with LA 106 northwest and north to its		
15	intersection with I-49 including its routing through Turkey Creek in Rapides and		
16	Evangeline parishes.		
17	(x) LA 3187 from its intersection with LA 13 west and north to the entrance		
18	of Crooked Creek Recreation Area in Evangeline Parish.		
19	(69) Zachary Taylor Parkway - Louisiana's Military History Byway:		
20	(a) LA 10 from the Mississippi state line west through Washington,		
21	Tangipahoa, St. Helena, and East Feliciana Parishes.		
22	(b) LA 10 from the West Feliciana Parish line west to the intersection with		
23	LA 10 and LA 61.		
24	(c) LA 61 south to the intersection of LA 61 and LA 10 at the John James		
25	Audubon Bridge.		
26	(d) LA 10 west continuing over the John James Audubon Bridge into Pointe		
27	Coupee Parish to the intersection of LA 10 and LA 1.		
28	(e) LA 1 west through Avoyelles Parish to the intersection of LA 1 and		
29	Broadway Avenue in Rapides Parish.		

1	(f) South of Broadway Avenue to the intersection of Broadway and Interstate
2	<u>49.</u>
3	Section 2. R.S. 56:1948.5(2), (15), (57), and (60) are hereby repealed in their
4	entirety.

Abstract: Repeals present highway designations for the Myths and Legends Byway and the Zydeco Cajun Prairie Byway and enacts new highway designations for both. Enacts the Zachary Taylor Parkway - Louisiana's Military History Byway.

<u>Proposed law</u> provides that certain highways and sections of highways are designated as the Zachary Taylor Parkway - Louisiana's Military History Byway.
