PORTS/SOUTH LOUISIANA: Increases the membership of the Port of South Louisiana Commission

AN ACT

To amend and reenact R.S. 34:2471(A)(introductory paragraph), (6), (7), and (8) and to 2 3 enact R.S. 34:2471(A)(9), relative to the Port of South Louisiana Commission; to 4 increase the membership on the commission; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 34:2471(A)(introductory paragraph), (6), (7), and (8) are hereby 7 amended and reenacted and R.S. 34:2471(A)(9) is hereby enacted to read as follows: 8 §2471. Creation; membership 9 A. There is hereby created the Port of South Louisiana, as a political 10 subdivision of the state, with jurisdictional authority encompassing the geographical 11 boundaries of the parishes of St. Charles, St. John the Baptist, and St. James. The 12 Port of South Louisiana shall be governed by a board of seven members who shall 13 be appointed as follows: 14 15 (6) Two members shall be appointed by the governor at his sole discretion. 16 (6) (7) From the nominees submitted to the governor for appointment he 17 shall select one resident from each parish located within the territorial jurisdiction of the port, one of whom may, instead of residency, be the chief executive officer of 18 19 a business which is principally operated within such parish.

(7) (8) Each appointment shall be submitted to the Senate for confirmation.

(8) (9) The terms of all commissioners shall be concurrent with that of the governor. Any subsequent vacancy on the commission for any reason shall be filled for the unexpired portion of the term in the same manner as the original appointment.
