SCHOOLS EG NO IMPACT See Note Provides for the Louisiana Expectant and Parenting Students Act. (8/1/16)

Proposed legislation establishes the Louisiana Expectant and Parenting Students Act to recognize existing Federal Title IX obligations and policy provisions that shall be adopted by governing authorities of public secondary schools, including charter schools, with respect to such students. Requires each governing authority to make available to the public by posting such policy on the school websites or other appropriate means. Directs the Department of Education to submit a written report to the Senate and House committees on education and health and welfare at least sixty days prior to the 2017 Regular Session which shall include the level of compliance, a summary of aggregate data related to the graduation rates of expectant and parenting students and any recommendations for changes to policy or legislation.
