2	To enact R.S. 24:55(H) and R.S. 49:76(H), relative to lobbying; to provide relative to

5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 24:55(H) is hereby enacted to read as follows:

9	H. If the name of a legislator is included in a report because expenditures
10	were attributed to the legislator or to his spouse or minor child and the legislator,
11	spouse, or minor child was invited but did not actually attend the function where the
12	expenditures were made, the report shall include a statement indicating that the
13	legislator, spouse, or minor child included in the report did not attend the function.
14	Section 2. R.S. 49:76(H) is hereby enacted to read as follows:

**Abstract:** Requires lobbyists to include in reports information concerning officials and family members who are invited but do not attend certain lobbying functions.

<u>Present law</u> (R.S. 24:50 et seq.) regulates lobbying of the legislature. <u>Present law</u> (R.S. 49:71 et seq.) regulates lobbying of the executive branch. Requires each lobbyist to register and provide certain identifying information for the lobbyist and the lobbyist's clients and certain information concerning lobbying activities.

<u>Present law</u> (R.S. 24:55 and R.S. 49:76) requires each lobbyist to file monthly reports containing certain specified information regarding expenditures incurred for the purpose of lobbying. Requires the lobbyist to include expenditures attributable to each individual official who is lobbied, as well as expenditures attributable to the spouse or minor child of the official. Requires the name of the official to be included, but not the name of the spouse or minor child.

Proposed law retains present law.

<u>Proposed law</u> provides that if the name of an official is included in a report because expenditures were attributed to the official or to his spouse or minor child and the official, spouse, or minor child was invited but did not actually attend the function where the expenditures were made, the report shall include a statement indicating that the official, spouse, or minor child did not attend the function.

<u>Present law</u> provides for enforcement by the Board of Ethics. Provides for the imposition of penalties for failing to include information required to be in a report.

Proposed law makes present law penalties applicable to proposed law.
