1	AN ACT
2	To authorize and provide for the transfer of certain state rights and property in Orleans
3	Parish; to provide for the applicable property descriptions; to provide for reservation
4	of mineral rights; to provide terms and conditions; to provide an effective date; and
5	to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. Notwithstanding any other provision of law to the contrary, the
8	<u>commissioner of administration and the secretary of the Department of Transportation</u>
9	and Development are hereby authorized and empowered, for and on behalf of the state
10	of Louisiana, to convey, transfer, assign, lease, or deliver to the governing authority of
11	the City of New Orleans in Orleans Parish a servitude of use over the following
12	described parcels of property and any surface improvements situated thereon:

lease or delivery of title, excluding mineral rights, to the property described in Sections
<u>1</u> and 2 in compliance with the directive and authorization of the U.S. Department of
Transportation under 49 U.S.C. 5334(h) and subject to the requirements thereof.
Section 4. In the event that the agreement authorized by this Act is not entered
into on or before December 31, 2018, the authorization to convey, transfer, assign,
lease, or deliver any interest in the property pursuant to this Act shall terminate and
be null and void on that date and thereafter.
Section 5. This Act shall become effective upon signature by the governor or, if not
signed by the governor, upon expiration of the time for bills to become law without signature
by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
vetoed by the governor and subsequently approved by the legislature, this Act shall become
effective on the day following such approval.

Proposed law authorizes the commissioner of administration and the secretary of DOTD to grant a servitude to the City of New Orleans over certain property in Orleans Parish known as the Jackson Avenue Ferry Terminal.

Proposed law authorizes the transfer of certain property, excluding mineral rights, in Orleans Parish known as the Jackson Avenue Ferry Terminal from DOTD to the Port of New Orleans.

Effective upon signature of the governor or lapse of time for gubernatorial action.
