5	(c) Maintains continuous, uninterrupted accreditation through an approved

7	(d) Maintains continuous, uninterrupted enrollment with the statewide
8	management organization for the Louisiana Behavioral Health Partnership.
9	(15) An individual licensed advanced practice registered nurse, or a group
10 11 12	practice of licensed advanced practice registered nurses, providing services under the auspices of and pursuant to the scope of the individual's license or group's licenses.
13	(16) Rural health clinics licensed under R.S. 40:2197.
14 15	(17) Facilities or services operated by the Department of Public Safety and Corrections, corrections services.
16	(18) Facilities or services operated for the sole purpose of providing
17 18	substance abuse or mental health services to courts that are recognized and certified by the Louisiana Supreme Court as specialty courts."
