WEAPONS/HANDGUNS OR SEE FISC NOTE LF RV
Creates the crime of failure to identify the possession of a concealed handgun to a law enforcement officer

<u>Proposed law</u> requires a person authorized to possess a concealed handgun pursuant to present law to notify uniform law enforcement officers of the weapon, submit to a pat down, and allow the officer to disarm them. <u>Proposed law</u> provides for up to a \$1,000 fine if the person does not notify a uniformed law enforcement officer of a concealed firearm. <u>Proposed law</u> defines "law enforcement officer" and "peace officer."

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

The proposed legislation may result in an indeterminable increase in local funds revenue as result of potential fines. The proposed law creates the misdemeanor of failing to notify a uniformed law enforcement officer of a concealed firearm. The maximum fine assessed for failing to notify a uniformed law enforcement officer of a concealed firearm is \$1,000. The potential revenue will accrue to the local governing authority.
