12	(4) "License type" means the type of license applied for or held by a
13	specialized provider, which shall include Type 1, <b>Type II</b> , and Type IV.

15	(12) "Victim of human trafficking" means a person who has not yet
16	reached the age of twenty-one or otherwise been legally emancipated who has
17	been determined by a court of competent jurisdiction or is the subject of an

3	whose residents consist solely of victims of human trafficking.

5	§1404. Requirement of license
6	A. All specialized providers, including facilities owned or operated by any
7	governmental, profit, nonprofit, private, or church agency, shall be licensed.
8	Specialized provider licenses shall be of two three types: Type I, Type II and Type
9	IV.

11	§1406. Licenses; application; temporary or provisional; fees
12	A. Application for licensure of a new specialized provider shall be made by
13	the specialized provider to the department upon forms furnished by the department.
14	Upon receipt of the application for a license and verification that minimum
15	requirements for such license as established by rule are satisfied, and that the
16	specialized provider is in compliance with all other state and local laws and
17	regulations, the department shall issue a Type I, Type II or Type IV license for such
18	period as may be provided for by rule.

20	§1416. Special, temporary, or continued care for children
21	Any institution, society, agency, corporation, facility, person or persons, or
22	any other group licensed in accordance with the provisions of this Chapter may
23	receive children or victims of human trafficking from their parents or legal
24	guardians or from the courts for special, temporary, or continued care.
