16 "(3) A contracting entity that is removed from the list of approved 17 contracting entities may appeal its removal to the Legislative Audit Advisory 18 Council. If the Legislative Audit Advisory Council receives such an appeal, it shall 19 conduct a public hearing on the matter. If the Legislative Audit Advisory Council 20 determines that the contracting entity was wrongfully removed from the list of 21 approved contracting entities, the legislative auditor shall immediately place the 22 contracting entity on the list of approved contracting entities."
