Proposed law provides that proper venue for all administrative hearings relative to the licensing, certification, discipline or registration of any regulated profession and occupation regulated by present law will be the parish wherein the licensee or certificate holder is domiciled.

EXPENDITURE EXPLANATION

The proposed law will result in an indeterminable significant increase in Fees and Self-generated expenditures for any agency, board or commission that regulates any profession or occupation per Title 37. Proposed law provides that all administrative hearings relative to the licensing, certification, discipline or registration of any profession and occupation regulated in Title 37 shall be the parish wherein the licensee or certificate holder is domiciled.

Anticipated expenditures associated with proposed law include but are not limited the following: 1) Travel expenditures for board members, staff or hearing appointees of each regulatory entity to conduct administrative hearings at various locations for an unspecified frequency annually. These expenditures may include mileage or vehicle rental, meals, per diem, and hotel accommodations when applicable; 2) Rental Space to conduct meetings. Each regulatory entity may be required to conduct administrative hearings in any parish for an unspecified frequency annually.

There is no anticipated direct material effect on governmental revenues as a result of this measure.
