STATE AGENCIES: (Constitutional Amendment) Authorizes certain budget reduction actions to avoid a deficit if a deficit has been projected

2	Proposing to add Article VII, Section 10(F)(5) of the Constitution of Louisiana, to provide		
3	for avoidance of a budget deficit; to authorize certain actions with respect to		
4	employment and compensation when a deficit has been projected; to provide for		
5	submission of the proposed amendment to the electors; and to provide for related		
6	matters.		
7	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members		
8	elected to each house concurring, that there shall be submitted to the electors of the state of		
9	Louisiana, for their approval or rejection in the manner provided by law, a proposal to add		
10	Article VII, Section 10(F)(5) of the Constitution of Louisiana, to read as follows:		
11	§10. Expenditure of State Funds

16	(5)(a) If a deficit is projected pursuant to this Paragraph, the governor,		
17	subject to approval of the Joint Legislative Committee on the Budget, if the

1	salary of all persons holding elective or appointive positions in state government and	
2	all state government employees, whether classified or unclassified, by not more than	
3	one percent; such reductions shall be taken from the state general fund, dedicated	
4	funds, fees, or self-generated revenue. Such action shall remain in effect until the	
5	end of the fiscal year or as otherwise provided by the action, whichever is later.	
6	(b) All revenue savings realized from an action taken pursuant to this	
7	Subparagraph shall be retained in or transferred to the state general fund and used to	
8	reduce or eliminate the deficit. All revenue saved in excess of the amount needed	
9	to eliminate the deficit may be appropriated in the next fiscal year.

11	Section 2. Be it further resolved that this proposed amendment shall be submitte	
12	to the electors of the state of Louisiana at the statewide election to be held on November 8

14	Section 3. Be it further resolved that on the official ballot to be used at the election,	
15	there shall be printed a proposition, upon which the electors of the state shall be permitted	
16	to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as	
17	follows:

19	reduce salaries of state officials and state employees in order to avoid a

Abstract: Authorizes the governor, with Joint Legislative Committee on the Budget (JLCB) approval, or the legislature, to reduce all state salaries by up to 1% if a budget deficit is projected.

<u>Present constitution</u> provides for the Revenue Estimating Conference which is responsible for developing the official forecast of state revenue available for appropriation. Requires the legislature to provide by law for procedures to determine if appropriations will exceed forecasted revenues and methods of adjusting appropriations to eliminate the projected deficit.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Proposed constitutional amendment</u> retains <u>present constitution</u> and additionally authorizes, if a budget deficit is projected, the governor subject to JLCB approval if the legislature is not in session, or the legislature by law if it is in session, to reduce the salary of all persons holding elective or appointive state positions and all state government employees by up to 1%.

<u>Proposed constitutional amendment</u> provides that such actions remain in effect until the end of the fiscal year or as otherwise provided by the action, whichever is later. Requires that savings realized shall be retained in or transferred to the state general fund and used to reduce or eliminate the deficit; however, authorizes appropriation of revenue saved in excess of the amount needed to eliminate the deficit in the next fiscal year.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Nov. 8, 2016.
