
EXPENDITURE EXPLANATION

Proposed law may result in an indeterminable decrease in SGF and other MOF expenditures during FY 17 and FY 18. Proposed law requires that no new employment position shall be created in the executive or legislative branch of state government, except institutions of higher education and their management boards, from August 1, 2016, through June 30, 2018.

The number of new employment positions within the executive and legislative branches that may be created within the specified time frame is unknown. To the degree that a position may have been created except for the provisions of proposed law, the state would not incur additional expenditure requirements associated with those positions. Because these positions do not exist within the existing authorized schedule of T.O. positions, such a provision does not result in a cost savings compared to existing funding levels but instead precludes the creation of additional personal services expenditure obligations.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
