**Purpose of the Bill:** The proposed law would allow for: 1) a schedule of fees, depending upon the size of the document (number of pages), 2) specifications regarding the documents paper size (letter, legal, other), 3) that if a document must be recorded and filed in both the mortgage and conveyance records, the fees shall be assessed separately for recording in the mortgage records and the conveyance records, 4) a \$50 filing fee for recording an act or affidavit to cancel a mortgage, lien or privilege, 5) the fees shall include the indexing of documents filed for record for up to 10 names, and include one clerkcertified copy of the recorded document without additional charge, and 6) a schedule of fees to be charged by clerks as ex officio recorders and by ex officio notaries public.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

An official with the Louisiana Clerks of Court Association, indicated they do not anticipate an increase or decrease of expenditures as a result of this bill.

An official with the Jefferson Parish Clerk's Office, indicated they do not anticipate an increase or decrease of expenditures as a result of this bill.

An official with the Bossier Parish Clerk's Office, indicated that they do not know how may pages would be filed. Therefore, it would be difficult to estimate the impact on expenditures.

## **REVENUE EXPLANATION**

This measure could impact the revenues collected by Clerk of Court Offices statewide, however the impact is indeterminable at this time. We contacted several Clerk of Court Offices and the LA Clerks of Court Association and obtained the following information:

Officials with the Jefferson and Bossier Parish Clerk of Court Offices, indicated the impact of the bill cannot be determined.

An official with the LA Clerks of Court Association indicated there are so many unknown factors making it difficult to estimate the impact on revenues (e.g., uncertainty as to the number of documents that will fall into the different categories). The official stated that in some instances the clerks will receive more and in some instances they will receive less than they are currently receiving.

Information contained in a worksheet prepared by the Association shows how the current law compares to the proposed law, using different number of pages, 10 names to be indexed, and 1 clerk certified copy of all pages in the document. A few examples are shown below.


