HOUSE BILLS ON FINAL PASSAGE - [9 items]

1. **HB3** **ABRAMSON** **CAPITAL OUTLAY** Provides for the Omnibus Bond Act (Item #4)
2. **HB8** **MAGEE** **TAX/SALES-USE, ST-EXEMPT** Provides for effectiveness of the exemption for purchases of fishing vessels, supplies, fuels, lubricants, and repairs for vessels by licensed commercial fishermen (Item #33)
3. **HB24** **ANDERS** **TAX/INSURANCE PREMIUM** Provides relative to the insurance premium tax credit (Item #6)
4. **HB25** **LYONS** **TAX/INCOME-CREDIT** Reduces the amount of the income tax credit for the Louisiana Citizens Property Insurance Corporation Assessment and makes the reduction permanent (Item #46)
5. **HB29** **PRICE** **REVENUE DEPARTMENT** Provides relative to the calculation of interest on certain overpayments (Item #45)
6. **HB35** **ANDERS** **TAX/INSURANCE PREMIUM** Establishes the annual minimum tax on health maintenance organizations (Item #5)
7. **HB51** **JIM MORRIS** **TAX/SALES-USE, STATE** Provides with respect to the effectiveness of certain exclusions and exemptions from state sales and use taxes (Items #7-34)
8. **HB52** **ABRAMSON** **CAPITAL OUTLAY** Provides with respect to the execution and administration of capital outlay appropriations for Fiscal Year 2016-2017 (Item #3)
9. **HB53** **ABRAMSON** **TAX** Provides with respect to sales of certain services and tangible personal property at certain publicly owned facilities (Item #35)
