Senate Resolutions 2nd Reading

- SR 20 PETERSON SENATE
Recognizes the 120th anniversary of the landmark United States Supreme Court Plessy v. Ferguson decision, and encourages President Barack Obama to bestow the Presidential Medal of Freedom posthumously upon Homer Adolph Plessy.
- SR 21 PERRY CONDOLENCES
Expresses condolences upon the death of Carol Ann "C.A." Deshotels.
- SR 22 MIZELL COMMENDATIONS
Commends Chloe Casnav upon her selection as a representative of Louisiana at the Huge O'Brian World Leadership Congress in Chicago, Illinois.
- SR 23 RISER SENATE
Commends Eugene Dunn upon the occasion of his retirement as the Caldwell Parish Clerk of Court.

Senate Bills 3rd Reading and Final Passage Subject to Call

- SB 8 MORRELL TAX/TAXATION
Provides for the operability of the tax credit for Citizens Property Insurance Corporation 2005 assessment. (gov sig) (Item Nos. 46 and 47)
- SB 13 MORRELL TAX/TAXATION
Legislates with regard to the net capital gains deduction. (gov sig) (Item No. 41)
- SB 14 MORRELL CAPITAL OUTLAY
Provides for the Omnibus Bond Act (gov sig) (Item #4)

House Bills 3rd Reading and Final Passage Subject to Call

- HB 50 MONTOUCET TAX/INCOME TAX
Reduces the individual income tax deduction for net capital gains (Item #41)
- HB 51 MORRIS, JIM TAX/SALES-USE, STATE
Provides with respect to the effectiveness of certain exclusions and exemptions from state sales and use taxes (Items #7-34)
- HB 53 ABRAMSON TAX
Provides with respect to sales of certain services and tangible personal property at certain publicly owned facilities (Item #35)

Instruments Pending Senate Conference

- SB 6 MORRELL TAX/AD VALOREM
Provides for the carry forward rather than the refund of a certain portion of the tax credit for ad valorem taxes paid on inventory. (gov sig) (Item #47)
- SB 10 WARD TAX/AD VALOREM
Provides for the confidentiality of tax records and the definitions of inventory and manufacturer for purposes of the tax credits for ad valorem taxes paid to local governments. (See Act) (Item #47)
