Provides for legislative oversight and adoption of proposed updates to the State Uniform Construction Code. (8/1/16)
- SB 367 CLAITOR JUVENILE JUSTICE
Provides relative to certain juveniles sentenced to life without parole. (gov sig)

| SB | 106 | BOUDREAUX | VITAL STATISTICS | Provides for the elimination of the short-form birth certification card. (gov sig) |

| SB | 109 | BARROW | EARLY CHILDHOOD ED | Provides for confidentiality of applications and client case records for child care assistance clients. (gov sig) |
| SB | 139 | RISER | MUSEUMS | Removes the Schepis Museum from the jurisdiction of the Department of State. (gov sig) |

| SB | 192 | JOHNS | INSURANCE DEPARTMENT | Provides for the confidential treatment of papers, documents, reports, or evidence related to an investigation by the division of insurance fraud within the Department of Insurance. (8/1/16) |
| SB | 195 | CORTEZ | TRANSPORTATION/DEV DEPT | Authorizes DOTD to solicit and enter into public-private partnership contracts. (gov sig) |
| SB | 199 | GATTI | INSURERS | Provides for prior approval by the commissioner of insurance for the merger of a domestic insurer or health maintenance organization. (8/1/16) |
| SB | 222 | CLAITOR | PUBLIC RECORDS | Provides that certain records in the custody of the Louisiana State Licensing Board for Contractors are exempt from the Public Records Law. (8/1/16) |
| SB | 224 | CLAITOR | COLLEGES/UNIVERSITIES | Repeals provisions regarding parking violations on campus declared unconstitutional. (gov sig) |
| SB | 227 | COLOMB | MOTOR VEHICLES | Provides for the issuance of REAL ID compliant driver's licenses and special identification cards. (gov sig) |
| SB | 236 | BARROW | CORONERS | Provides relative to admissions by emergency certificate of persons suffering from mental illness and substance abuse. (8/1/16) |
| SB | 246 | LAFLEUR | MUSEUMS | Transfers the Eddie G. Robinson Museum from the jurisdiction of the Department of State to the Board of Supervisors for the University of Louisiana System. (gov sig) |

Removes the Germantown Colony Museum from the jurisdiction of the Department of State. (2/1/17)
- SB 258 LUNEAU HEALTH/ACC INSURANCE
Provides for coverage for refills for prescription eye drops. (8/1/16)
- SB 266 LONG INSURANCE CLAIMS
Provides relative to the licensing of claims adjusters. (See Act)

- SR 6 BARROW HEALTH CARE
Directs the Department of Health and Hospitals to evaluate and report on funding solutions for in-home support providers.

Senate Concurrent Resolutions Reported by Committee

- SCR 3 MILLS HEALTH/HOSPITALS DEPT
Directs the Department of Health and Hospitals to submit a report by May 1, 2016, and to add Adrenoleukodystrophy (ALD) to the newborn screening panel no later than January 1, 2017.
- SCR 4 BARROW HEALTH SERVICES
Continues the task force to study and make recommendations concerning health services delivery and financing in the Baton Rouge region.
- SCR 11 BOUDREAUX VITAL STATISTICS
Directs the Department of Health and Hospitals to evaluate and report on increasing access to vital records at parish health units.

- SB 3 PEACOCK FIREFIGHTERS RETIREMENT
Provides benefits for members hired on or after January 1, 2017. (6/30/16)
- SB 4 PEACOCK TEACHERS RETIREMENT
Provides for the frequency of meetings of the board of trustees. (6/30/16)
- SB 6 PEACOCK SCHOOL EMPLOYEES RET
Provides relative to contributions of members out of service for five years. (6/30/16)
- SB 7 PEACOCK SCHOOL EMPLOYEES RET
Provides relative to certain purchases of service credit. (2/3 - CA10s29(F)) (6/30/16)
- SB 12 PEACOCK STATE POLICE RET FUND
Removes redundant provisions of law and makes technical changes. (6/30/16)
- SB 13 PEACOCK MUNICIPAL EMPLOYEE RET
Provides for the commissioner of administration and the treasurer to be voting members of the board of trustees. (6/30/16)
