Senate Resolutions 2nd Reading

- SR 12 CARTER, T. SPECIAL DAY/WEEK/MONTH
Designates June 1, 2018, as National Gun Violence Awareness Day.
- SR 13 CORTEZ COMMENDATIONS
Commends Rosabell Perron Boudreaux on her 100th birthday celebration on June 1, 2018.

- SCR 14 LONG COMMENDATIONS
Commends Larry Wright on being named to the 2018 Louisiana Sports Hall of Fame.

Senate Concurrent Resolutions Returned from House With Amendments

- SCR 4 ALLAIN TAX/ENERGY
Requests the Louisiana State University Center for Energy Studies, Louisiana State University Public Administration Institute, and the Louisiana Tax Institute to analyze mineral revenues, taxes, and exemptions and to submit a written report of its findings to the legislature.

Senate Bills 3rd Reading and Final Passage

- SB 1 ALLAIN FUNDS/FUNDING
Provides for the transfer, deposit, and use of monies among state funds.(7/1/18)
- SB 3 JOHNS TAX/TAXATION
Provides for administration of incentive rebates under the Quality Jobs and Enterprise Zone programs. (Items #21 and 27)(gov sig)
- SB 4 LAFLEUR FUNDS/FUNDING
Provides relative to the transfer, dedication, use, investment, and appropriation of funds in the state treasury. (Item #10) (gov sig)
- SB 5 LAFLEUR BONDS
Authorizes the securitization of the economic damage portion of the Deepwater Horizon income stream. (Item #30) (gov sig)
- SB 7 MORRELL TAX/TAXATION
Makes permanent reforms to the credit for individual income taxes paid in other states. (Item #17) (gov sig)
- SB 8 MORRELL TAX/TAXATION
Defines the term dealer for purposes of collecting and remitting use tax on remote sales. (Item #26) (gov sig)
- SB 13 WARD FISCAL CONTROLS
Provides relative to reporting of state expenditures through the fiscal transparency website. (Item #32) (7/1/18)
- SB 15 DONAHUE BUDGET PROCEDURE
Limits tax credit and rebate expenditures for certain tax incentive programs. (Item #21) (7/1/18)
- SB 20 RISER FUNDS/FUNDING
Provides relative to the Workers' Compensation Administrative Fund. (Item #11) (gov sig)
