Senate Resolutions 2nd Reading

- SR 23 LAFLEUR COMMENDATIONS
Commends Lillyanne Brignac on being selected as a candidate to represent Louisiana at the HOBY World Leadership Congress.
- SR 24 APPEL COMMENDATIONS
Commends Mary Guy of Metairie, Louisiana, for being selected as a candidate to represent Louisiana at the Hugh O'Brian Youth (HOBY) World Leadership Congress.

Senate Resolutions Reported by Committee Subject to Call

- SR 9 MORRELL MILITARY AFFAIRS
Requests the governor to recall troops and other assets of the Louisiana National Guard from the United States-Mexico border until all children separated from their families at the border pursuant to the zero-tolerance memorandum are reunited with their families and the practice of systematically separating children from their families ceases.

Senate Concurrent Resolutions to be Adopted Subject to Call

- SCR 3 PETERSON CONSTITUTION CONVENTION
Creates a commission to study the feasibility of a constitutional convention and to make recommendations thereto.
- SCR 5 BISHOP, W. EARLY CHILDHOOD ED
Establishes the Louisiana Early Childhood Learning Caucus.
- SCR 6 MORRELL TAX/SALES
Suspends the provisions of R.S. 47:321.1(E).

Senate Bills 3rd Reading and Final Passage Subject to Call

- SB 1 MORRELL TAX/SALES
Changes the effective date for the definition of "dealer" for purposes of the sales and use tax imposed on transactions involving a remote seller. (gov sig)

House Bills 3rd Reading and Final Passage

- HB 1 HENRY APPROPRIATIONS/GENERAL
Makes supplemental appropriations for Fiscal Year 2018-2019 (Item #3)
- HB 10 DAVIS TAX/SALES-USE, STATE
Provides for the rate and base for state sales and use taxes (Item #1)
