HOUSE BILLS ON FINAL PASSAGE - [13 items]

1. **HB372** **TALBOT** **INSURANCE/AUTOMOBILE** Enacts the Omnibus Premium Reduction Act of 2019
2. **HB457** **HOWARD** **HIGHWAYS** Provides for the designation of a strict speed enforcement zone in the village of Robeline
3. **HB481** **G.CARTER** **MTR VEHICLE/LICEN PLATES** Provides relative to specialty prestige license plates
4. **HB489** **DUBUISSON** **EVIDENCE** Provides relative to hearsay
5. **HB83** **J.HARRIS** **TAX CREDITS** Extends the sunset of the tax credit for rehabilitation of historic structures to January 1, 2026
6. **HB90** **MOSS** **TAX/TAX REBATES** Establishes "The Angela Downs Act" which authorizes a state sales tax rebate for purchases of motor vehicles with certain modifications related to orthopedic disabilities"
7. **HB102** **JONES** **HUMAN REMAINS** Provides relative to the disposition of the remains of a homicide victim
8. **HB155** **BERTHELOT** **FIRE PROTECT/FIRE MARSHAL** Provides with respect to fire department identification numbers and the submission of fire reports
9. **HB164** **FRANKLIN** **MTR VEHICLE/TRUCK REGS** Provides relative to dump trucks
10. **HB172** **PIERRE** **FIRE PROTECT/FIRE MARSHAL** Provides relative to the training, registration, and certification of fire-resistant material applicators
11. **HB209** **DAVIS** **TAX EXEMPTIONS** Authorizes a sales and use tax exemption for new automobiles, aircraft, boats, vessels or other water craft used as demonstrators
12. **HB273** **CARMODY** **CONTRACTORS/CONSTRUCTION** Provides relevant updates and technical corrections to statutes relative to contractors
13. **HB274** **G.CARTER** **TAX CREDITS** Establishes a tax credit pilot program for certain Louisiana-based manufacturing industries

HOUSE BILLS ON FINAL PASSAGE - [13 items]

1. **HB297** **HOWARD** **SECRETARY OF STATE** Provides relative to the secretary of state's office
2. **HB305** **FALCONER** **CONSUMERS/PROTECTION** Provides relative to telemarketing to elder persons and persons with disabilities
3. **HB309** **LEOPOLD** **MTR VEHICLE/LICEN PLATES** Creates the "Spanish Heritage" specialty license plate
4. **HB357** **JEFFERSON** **HIGHWAYS** Authorizes Grambling State University to redesignate Stadium and Facilities Drive, on the campus of Grambling State University, as "Doug Williams Drive"
5. **HB369** **PIERRE** **MTR VEHICLE/TRUCKS** Creates the Louisiana Trucking Research and Education Council
6. **HB391** **FOIL** **VETERANS** Provides for the certification of veteran-owned businesses
7. **HB425** **JACKSON** **ABORTION** (Constitutional Amendment) Stipulates that no provision of the constitution protects a right to abortion or requires the funding of abortion
8. **HB460** **TALBOT** **TAX CREDITS** Establishes an income and corporate franchise tax credit for purchase and installation of surveillance cameras in certain commercial vehicles
9. **HB464** **BERTHELOT** **AMUSEMENT PARKS** Provides relative to inflatable amusement devices, amusement attractions, and amusement rides
10. **HB494** **ABRAMSON** **TAX/SALES & USE** Provides relative to the determination of where sales and use taxes are due on purchases of certain raw materials converted into asphaltic concrete
11. **HB495** **ABRAMSON** **TAX/GAMING** Levies a state tax on the net gaming proceeds of fantasy sports contests, dedicates the avails of the tax, and authorizes a fee for issuance of certain licenses or permits
12. **HB498** **ABRAMSON** **TAX/GAMING** Levies a state tax on the net gaming proceeds of sports wagering, dedicates the avails of the tax, and provides for a fee
13. **HB507** **ABRAMSON** **TAX** Levies a 7% tax on the gross sales of therapeutic marijuana and dedicates the avails into the New Opportunities Waiver Fund
