Senate Concurrent Resolutions 2nd Reading

- SCR 28 ERDEY SPECIAL DAY/WEEK/MONTH
Designates May 28, 2019, as Certified Louisiana Day.
- SCR 29 ERDEY COMMENDATIONS
Commends Hailey Enamorado on being named a Distinguished Finalist in Louisiana for the 2019 Prudential Spirit of Community Awards program.
- SCR 30 BARROW SPECIAL DAY/WEEK/MONTH
Recognizes May 6-11, 2019, as National Economic Development Week.
- SCR 31 BARROW LEGIS POWERS/FUNCTIONS
Designates a lead agency over the Interagency Heroin and Opioid Coordination Plan.
- SCR 32 THOMPSON COMMENDATIONS
Commends the service and contributions of first responders in Louisiana and designates April 30, 2019, as First Responders Appreciation Day at the Louisiana State Capitol.

Senate Bills 3rd Reading and Final Passage

- SB 1 PEACOCK RETIREMENT BENEFITS
Provides for the investment of funds by the board of trustees for the Bossier City Police Pension and Relief Fund. (6/30/19)
- SB 13 JOHNS STATE POLICE RETIREMENT
Provides for a surviving spouse benefit to resume in certain circumstances. (2/3 - CA10s29(F)) (7/1/2019)
- SB 15 LONG STATE EMPLOYEE RET
Provides for firefighters at state agencies to be members of the hazardous duty plan. (2/3 - CA10s29(F)) (6/30/19)
- SB 19 BOUDREAUX HEALTH DEPARTMENT
Provides relative to criminal history record information obtained by the Louisiana State Board of Medical Examiners. (8/1/19)
- SB 36 MILLS HEALTH CARE
Provides relative to emergency departments. (8/1/19)
- SB 38 ERDEY HEARING AID DEALERS
Increases the number of hours of continuing education required for hearing aid dealers that may be taken on the internet or through correspondence courses from three continuing education units to seven units. (8/1/19)
- SB 53 JOHNS PHARMACEUTICALS
Provides relative to prescription monitoring information. (8/1/19)
- SB 99 BOUDREAUX PHARMACISTS
Provides relative to Board of Pharmacy member qualifications. (8/1/19)
- SB 198 PEACOCK TAX/SALES
Provides for administration, disposition, enforcement, and adjudication of state and local taxes and for the Board of Tax Appeals. (gov sig)
