SB 24 HARRIS, JIMMY TAX/TAXATION
Provides for eligibility for the Angel Investor Tax Credit for investments made in federal opportunity zones. (Item #19) (gov sig)

SB 10 MIZELL INTERNET
Provides relative to rural broadband high-speed internet access.

SB 12 FESI UNCLAIMED PROPERTY
Constitutional amendment to dedicate unclaimed property funds and to create the Louisiana Unclaimed Property Permanent Trust Fund.
(2/3 - CA13s1(A)) (Item #10) (7/1/21)

SB 18 FESI FUNDS/FUNDING
Dedication of unclaimed property funds and creation of Louisiana Unclaimed Property Permanent Trust Fund. (Item #10) (See Act)

SB 19 PEACOCK FUNDS/FUNDING
Provides for investment authority of the Treasurer for the Millennium Trust, the Rockefeller Wildlife Refuge Trust and Protection Fund, and the Russell Sage or Marsh Island Trust Fund. (Item #10) (8/1/20)

SB 20 WHITE, B FUNDS/FUNDING
Provides for the creation, transfer, dedication, deposit, and use of certain funds in the state treasury. (gov sig)
