Senate Resolutions 2nd Reading

- SR 13 HARRIS, JIMMY COMMENDATIONS
Commends the Louisiana Tumor Registry, the faculty of LSU Health Sciences Center in New Orleans, and the School of Public Health for their contributions to the fight against cancer.
- SR 14 PEACOCK COMMENDATIONS
Commends Walter "Walt" Leger III for his dedicated service to the citizens of New Orleans and the state of Louisiana.

Provides relative to the Angel Investor Tax Credit Program. (Item #19) (8/1/20)
- SB 21 MCMATH TAX/SALES
Provides for the amount of compensation dealers may retain for timely filing and remittance of state sales tax. (Item #30) (7/1/20)
- SB 24 HARRIS, JIMMY TAX/TAXATION
Provides for eligibility for the Angel Investor Tax Credit for investments made in federal opportunity zones. (Item #19) (gov sig)
- SB 26 HEWITT ECONOMIC DEVELOPMENT
Provides for an extension of the application deadline for the Quality Jobs Program. (Item #18) (7/1/20)

Reconsideration of Vetoed Bills

- SB 132 HENRY, CAMERON CONTRACTS
Provides for reporting to and approval of all state contracts valued at twenty-five million dollars or more annually by the Joint Legislative Committee on the Budget. (7/1/20)
- SB 395 CLOUD ADVERTISING
Provides relative to false, misleading, or deceptive acts or practices and the award of certain costs and fees to the attorney general. (8/1/20)
- SB 406 MIZELL TELECOMMUNICATIONS
Provides for rural access to broadband high-speed internet service. (gov sig)
- SB 418 TALBOT LIABILITY INSURANCE
Enacts the Omnibus Premium Reduction Act of 2020. (1/1/21)
