- SR 15 MORRIS, JAY CONDOLENCES
Expresses condolences on the death of Colonel Carey Dale Walker.
- SR 16 BARROW COMMENDATIONS
Commemorates the adoption of the flag of the United States on June 14, 1777, and recognizes National Flag Week, June 14-20, 2020, in Louisiana.

- SCR 19 CATHEY LEGIS POWERS/FUNCTIONS
Creates the Louisiana Sales Tax Simplification Task Force to develop a comprehensive plan to simplify Louisiana's sales tax administration and collection system.

Creates the Drug and Specialty Courts Commission.

- SB 5 JOHNS GAMING
Provides relative to promotional play wagers. (Item #36) (gov sig)
- SB 16 ABRAHAM TAX/AD VALOREM
Provides for cooperative endeavor agreements between local governmental subdivisions and other entities that may require payments in lieu of ad valorem taxes. (Item #28) (See Act)
- SB 17 HEWITT TAX/TAXATION
Provides relative to the Angel Investor Tax Credit Program. (Item #19) (8/1/20)
- SB 21 MCMATH TAX/SALES
Provides for the amount of compensation dealers may retain for timely filing and remittance of state sales tax. (Item #30) (7/1/20)
- SB 24 HARRIS, JIMMY TAX/TAXATION
Provides for eligibility for the Angel Investor Tax Credit for investments made in federal opportunity zones. (Item #19) (gov sig)
- SB 26 HEWITT ECONOMIC DEVELOPMENT
Provides for an extension of the application deadline for the Quality Jobs Program. (Item #18) (7/1/20)

- SB 12 FESI UNCLAIMED PROPERTY
Constitutional amendment to dedicate unclaimed property funds and to create the Louisiana Unclaimed Property Permanent Trust Fund.
(2/3 - CA13s1(A)) (Item #10) (7/1/21)
- SB 18 FESI FUNDS/FUNDING
Dedication of unclaimed property funds and creation of Louisiana Unclaimed Property Permanent Trust Fund. (Item #10) (See Act)
- SB 20 WHITE, B FUNDS/FUNDING
Provides for the creation, transfer, dedication, deposit, and use of certain funds in the state treasury.
(Item #11) (gov sig)

Reconsideration of Vetoed Bills

- SB 132 HENRY, CAMERON CONTRACTS
Provides for reporting to and approval of all state contracts valued at twenty-five million dollars or more annually by the Joint Legislative Committee on the Budget. (7/1/20)
- SB 395 CLOUD ADVERTISING
Provides relative to false, misleading, or deceptive acts or practices and the award of certain costs and fees to the attorney general. (8/1/20)
- SB 406 MIZELL TELECOMMUNICATIONS
Provides for rural access to broadband high-speed internet service. (gov sig)
