SR 17 BOUDREAUX COMMENDATIONS
Commends Norris Joseph Broussard Sr. as he celebrates his 100th birthday.

Senate Concurrent Resolutions 2nd Reading

SCR 20 CATHEY EDUCATION DEPARTMENT
Requests the Department of Education to assist certain public school boards to enter into cooperative agreements for the provision of essential services.

SCR 21 MILLS, ROBERT COMMENDATIONS
Commends Benton High School Lady Tigers girls basketball team on winning the Class 5A state championship.

House Bills on Second Reading to be Referred

HB 11 STEFANSKI TAX/SALES & USE
Provides for the amount of compensation persons required to collect state sales and use tax may deduct for remitting taxes (Item #30)

HB 13 WRIGHT TAX CREDITS
Authorizes certain retail businesses to participate in the Enterprise Zone incentive (Item #18)

HB 16 ECHOLS TAX CREDITS
Establishes a tax credit for eligible expenses incurred in the rehabilitation of historic structures included on the National Register of Historic Places (Item #19)

HB 19 PRESSLY TAX/TAX REBATES
Extends eligibility requirements for certain industries to participate in the Quality Jobs Program (Item #18)

HB 28 DWIGHT TAX/AD VALOREM TAX
Authorizes agreements between political subdivisions and taxpayers that may provide for certain payments in lieu of ad valorem taxes (Item #28)

HB 35 BISHOP, S. FUNDS/FUNDING
Creates the Capital Outlay Savings Fund (Items #10 and #11)

HB 36 IVEY TAX/AD VALOREM-EXEMPTION
(Constitutional Amendment) Establishes certain property tax exemptions for capital investment projects (Item #28)

HB 37 HARRIS, LANCE REVENUE DEPARTMENT
Requires the Department of Revenue to waive penalties and interest for certain taxpayers for tax years 2019 and 2020 (Item #29)

HB 50 IVEY TAX/AD VALOREM TAX
Authorizes local taxing authorities to enter into cooperative endeavor agreements that provide for payments in lieu of taxes (Item #28)

HB 54 IVEY TAX/AD VALOREM-EXEMPTION
Provides for ad valorem tax exemptions for certain capital investment projects (Item # 28)

HB 64 STEFANSKI TAX/GAMING
Levies a state tax on the net revenue of fantasy sports contests (Item #17)

House Concurrent Resolutions 2nd Reading

HCR 5 FREEMAN LEGISLATIVE AFFAIRS
Requests a study of the continuity of government provisions by the house and senate governmental affairs committees, meeting jointly

HCR 6 WRIGHT U.S. CONSTITUTION
Calls for a convention to amend the United States Constitution to establish a limitation on terms for members of congress

HCR 8 JAMES JOINT RULES
Requires all fiscal notes to be requested in writing and requires the name of the person who requested the fiscal note to appear on the face of the fiscal note

- HCR 10 BAGLEY SCHOOLS/BUS OPERATORS
Requests governing authorities of public schools to continue operational pay for school bus operators during emergencies
- HCR 11 FONTENOT COASTAL RES/COASTAL ZONE
Memorializes the U.S. Congress and the Louisiana congressional delegation to remove the revenue sharing cap on the Gulf of Mexico Energy Securities Act of 2006 for Gulf producing states and to take such actions as are necessary to rectify the federal revenue sharing inequities between energy producing states
- HCR 12 GAROFALO WORKFORCE DEVELOPMENT
Directs the Louisiana Workforce Investment Council to study and submit a report to the legislature relative to funding and programs for workforce development
- HCR 16 BOURRIAQUE FUNDS/FUNDING
Memorializes Congress and the Louisiana congressional delegation to clarify the eligibility of freshwater fisheries impacted by the COVID-19 pandemic to receive CARES Act dollars

Provides for the emergency suspension of time limitations in certain civil proceedings (Item #40)

- HB 21 MAGEE COMMERCIAL REGULATIONS
Provides relative to motor vehicle repairs (Item #39)
- HB 27 ZERINGUE COURTS/COURT REPORTERS
Provides relative to the creation of the certified shorthand reporters fund (Items #10 and #11)
- HB 39 DAVIS UTILITIES

Reconsideration of Vetoed Bills

- SB 132 HENRY, CAMERON CONTRACTS
Provides for reporting to and approval of all state contracts valued at twenty-five million dollars or more annually by the Joint Legislative Committee on the Budget. (7/1/20)
- SB 395 CLOUD ADVERTISING
Provides relative to false, misleading, or deceptive acts or practices and the award of certain costs and fees to the attorney general. (8/1/20)
- SB 406 MIZELL TELECOMMUNICATIONS
Provides for rural access to broadband high-speed internet service. (gov sig)
- SB 418 TALBOT LIABILITY INSURANCE
Enacts the Omnibus Premium Reduction Act of 2020. (1/1/21)
