Senate Concurrent Resolutions 2nd Reading

SCR 22 CARTER, TROY CONGRESS
Memorializes Congress to extend the certification for an 8(a) business by one additional year if the business was certified by January 1, 2020.

HB 55 JOHNSON, MIKE MTR VEHICLE/SEAT BELTS
Provides relative to evidence of causation from nonuse of a safety belt (Item #40)

HB 62 ZERINGUE UNEMPLOYMENT COMP
Provides for state income tax withholdings on unemployment compensation benefits (Item #32)

HB 65 WRIGHT EMPLOYMENT
Requires short-term COVID-19 occupational forecasts (Item #15)

HB 68 DESHOTEL TAX CREDITS
Establishes an income or corporation franchise tax credit for certain broadband coverage providers (Item #31)

HB 69 DESHOTEL TAX/SALES-USE-EXEMPT
To provide for a sales and use tax exemption on the sale of certain fiber-optic cables (Item #31)

HB 70 JENKINS TAX/TAX REBATES
Extends Enterprise Zone Program incentives to essential critical infrastructure workers by authorizing the payment of a one-time hazard pay rebate (Item #18)

House Concurrent Resolutions 2nd Reading

HCR 7 IVEY LEGISLATIVE AGCY/LAW INST
Directs the Louisiana State Law Institute to study the Constitution of Louisiana and make recommendations to the legislature regarding transitional and outdated language that can be removed or changed without affecting the effect of the constitutional provisions

HCR 17 CARPENTER EMPLOYMENT
Requests certain state agencies and private businesses to recognize the value that justice-involved persons bring to the workforce and society, and to act with the intention to empower, train, and employ such individuals

HCR 23 BAGLEY COMMENDATIONS
Commend Louisiana State University Health Sciences Center at Shreveport for its extraordinary response to the COVID-19 pandemic

HCR 24 BAGLEY SPECIAL DAY/WEEK/MONTH
Designates Sunday, July 26, 2020, as Americans with Disabilities Act Awareness Day in Louisiana

SCR 11 REESE EMPLOYMENT
Urges and requests certain state agencies and private businesses in Louisiana to recognize the value that justice-involved persons can bring to the workforce and society and to act with intention to empower, train, and employ such individuals.

SCR 13 CARTER, TROY WORKFORCE COMMISSION
Requests the Louisiana Workforce Commission to distribute information regarding the provisions of the Families First Coronavirus Response Act that provides paid sick time to employees who are unable to work due to the effects of COVID-19.

Suspends certain provisions of law relative to the jury trial threshold. (Item #40)

Senate Bills 3rd Reading and Final Passage Subject to Call

- SB 12 FESI UNCLAIMED PROPERTY
Constitutional amendment to dedicate unclaimed property funds and to create the Louisiana Unclaimed Property Permanent Trust Fund.
(2/3 - CA13s1(A)) (Item #10) (7/1/21)
- SB 18 FESI FUNDS/FUNDING
Dedication of unclaimed property funds and creation of Louisiana Unclaimed Property Permanent Trust Fund. (Item #10) (See Act)
- SB 20 WHITE, B FUNDS/FUNDING
Provides for the creation, transfer, dedication, deposit, and use of certain funds in the state treasury.
(Item #11) (gov sig)

House Bills 3rd Reading and Final Passage

- HB 5 MARINO CIVIL/LAW
Provides for the emergency suspension of time limitations in certain civil proceedings (Item #40)
- HB 6 IVEY FUNDS/FUNDING
Establishes the State Cybersecurity and Information Technology Fund and dedicates revenues to the fund (Items #10 and #11)
- HB 21 MAGEE COMMERCIAL REGULATIONS
Provides relative to motor vehicle repairs (Item #39)
- HB 27 ZERINGUE COURTS/COURT REPORTERS
Provides relative to the creation of the certified shorthand reporters fund (Items #10 and #11)
- HB 39 DAVIS UTILITIES
Provides relative to the Louisiana Electric Utility Investment Recovery Securitization Act (Item #35)
- HB 57 SCHEXNAYDER CIVIL/ACTIONS
Enacts the Civil Justice Reform Act of 2020 (Item #40)

Reconsideration of Vetoed Bills

- SB 132 HENRY, CAMERON CONTRACTS
Provides for reporting to and approval of all state contracts valued at twenty-five million dollars or more annually by the Joint Legislative Committee on the Budget. (7/1/20)
- SB 395 CLOUD ADVERTISING
Provides relative to false, misleading, or deceptive acts or practices and the award of certain costs and fees to the attorney general. (8/1/20)
- SB 406 MIZELL TELECOMMUNICATIONS
Provides for rural access to broadband high-speed internet service. (gov sig)
- SB 418 TALBOT LIABILITY INSURANCE
Enacts the Omnibus Premium Reduction Act of 2020. (1/1/21)
