Introduction of Senate Bills

- SB 1 WARD TAX/AD VALOREM
Extends the carryforward period for the inventory tax credit for certain businesses. (1/1/21) (Items #26 and #65)
- SB 2 CATHEY TAX EXEMPTIONS
Exempts purchases of utilities by commercial farmers and agricultural manufacturers impacted by a declared state of emergency or disaster from state sales and use tax. (gov sig) (Item #26)
- SB 3 CATHEY TAX EXEMPTIONS
Exempts business utilities from state sales tax for businesses impacted by 2020 states of disaster or emergency. (gov sig) (Item #26)
- SB 4 CATHEY TAX EXEMPTIONS
Exempts purchases of certain farm equipment from the state sales and use tax during a declared state of emergency or disaster. (gov sig) (Item #26)
- SB 5 HEWITT PORTS/HARBORS/TERMINALS
Authorizes Plaquemines Port, Harbor and Terminal District to apply for designation as a foreign trade zone. (See CA3s19) (Item #47)
- SB 6 LAMBERT CAPITAL OUTLAY
Provides for capital outlay requests for a state-owned and administered project submitted by a budget unit of the state. (gov sig) (2/3-CA7s11(C)) (Item #15)
- SB 7 HEWITT PORTS/HARBORS/TERMINALS
Provides relative to the Louisiana International Deep Water Gulf Transfer Terminal Authority. (1/1/21) (Item #50)
- SB 8 CATHEY TAX EXEMPTIONS
Exempts purchases of utilities by businesses in the parishes impacted by Hurricane Laura from state sales and use tax. (gov sig) (Item #26)
- SB 9 CATHEY TAX EXEMPTIONS
Exempts purchases of construction materials from state sales and use tax in parishes impacted by certain disasters. (gov sig) (Item #26)
- SB 10 HEWITT ETHICS
Provides for certain exceptions from Code of Governmental Ethics. (gov sig) (Item #48)
- SB 11 CATHEY SCHOOLS
Prohibits certain schools from being members of any interscholastic extracurricular athletic association or organization that does not have certain persons as members of its executive committee. (gov sig) (Item #42)
- SB 12 MILLS, ROBERT HEALTH CARE
Provides access for patients of hospitals and residents of nursing homes, assisted living facilities, and other adult residential care homes to members of the clergy who volunteer to minister and provide religious sacraments and services, counseling, and mental health support during COVID-19 and other public health emergencies. (gov sig) (Item #28)
