SB	1	MIGUEZ	WEAPONS	Provides relative to the right of law-abiding citizens to carry concealed weapons lawfully without a permit. (8/1/24) (Item #18)
SB	2	MIGUEZ	LIABILITY	Provides relative to liability for persons authorized to carry a concealed handgun. (gov sig) (Item #19)
SB	3	CLOUD	PROBATION/PAROLE	Lowers the age for consideration as a juvenile in the criminal justice system. (gov sig) (2/3 - CA5s19) (Item #11)
SB	4	CLOUD	JUVENILE JUSTICE	Provides relative to disposition of a juvenile after adjudication of certain felony-grade delinquent acts. (3/1/24) (Item #11)
SB	5	MCMATH	PROBATION/PAROLE	Provides for parole proceedings and revocation of parole in certain cases. (8/1/24) (Item #4)
SB	6	SEABAUGH	LIABILITY	Provides for limitation of civil liability for certain peace officers. (gov sig) (Item #13)
SB	7	EDMONDS	DWI	Provides relative to penalties for the crime of operating a vehicle while intoxicated. (7/1/24) (Item #16)
SB	8	REESE	PUBLIC DEFENDER	To create the office of state public defender and transfer authority from the Louisiana Public Defender Board. (gov sig) (Item #7)
SB	9	MIZELL	CRIMINAL PROCEDURE	Provides time limitations for the initiation of prosecution of certain sex offenses. (gov sig)(Item #22)
SB	10	CATHEY	CRIME/PUNISHMENT	Reduces good time earned by prisoners sentenced for the death of a peace officer or first responder. (gov sig) (Item #2)
SB	11	CATHEY	JUVENILE JUSTICE	Lowers the age for consideration as a juvenile in the criminal justice system. (2/3 - CA5s19) (gov sig) (Item #11)
SB	12	HODGES	CRIME/PUNISHMENT	Increases the penalties for the crime of carjacking. (7/1/24) (Item #9)
SB	13	SEABAUGH	CRIMINAL JUSTICE	Creates the Truth and Transparency in the Louisiana Criminal Justice System Program. (5/1/24) (Item #5)
