1. **HB55** **CHARLES OWEN** **VITAL RECORDS/BIRTH CERT** Designates Act No. 470 of the 2022 Regular Session as "The Jean and Elise Act"

9. **HB539** **BOYER** **TRAFFIC/VIOLATIONS** Provides relative to pedestrians walking on highways during certain periods of the day
10. **HB589** **GALLE** **MTR VEHICLE/DRIVER LIC** Prohibits a commercial learner's permit or driver's license if not cleared by the Federal Motor Carrier Safety Administration, Drug and Alcohol Clearinghouse
